Trial Location

The trial will be held at the Good Match Farms, 5861 Pickering Road, Courtenay. It will be indoors on a dirt surface.

Directions coming from North or South: Travelling on the Inland Island Highway, stay on Highway until Exit 127 (the Piercy Road exit). Follow it about 5km to Headquarters Road. Turn right onto Headquarters Road, turn left at the next road (Vanier) to Highway 19A, continue north until Graham Road. Turn right on Pickering Road and follow our agility signs to Good Match Farms.

From Courtenay Centre: On Old Island Highway travelling north, take a right at Graham Road, then another right onto Pickering Road.

In consideration of the acceptance of this entry by AAC and the TailBlazers Agility Training (the “Organizing Club”) and the opportunity to have the Dog participate, compete in and/or be judged at this event or trial (the “Event”), I, the undersigned, agree as follows:

1. I certify that I am the actual owner of the Dog, or that I am the duly authorized agent of the actual owner of the Dog and that the Dog is not a hazard to persons, property or other dogs.
2. I agree that AAC or the Organizing Club for the Event may refuse my entry for any reason that it deems to be sufficient.
3. I understand and acknowledge that participation in the Event carries certain risks, including, but not limited to, injuries (including serious injuries and death) to myself, the Dog, another dog under my control or persons attending as my guests (my “Related Parties”), damage to property and other losses. I waive any and all claims that I have or may have in the future against, and release from all liability and agree not to sue AAC, the Organizing Club or any of the directors, executives, committees, representatives, employees, volunteers or agents of either AAC or the Organizing Club (the “Personnel”) for any injury, death, property damage or other loss that I or my Related Parties sustain due to any cause whatsoever, including negligence, breach of contract, breach of duty, statutory or otherwise, or mistakes or errors of judgment of any kind.
4. I assume full responsibility for the conduct of myself and my Related Parties during the entirety of the Event. I agree to indemnify and save harmless AAC, the Organizing Club and the Personnel from and against any and all claims that may be made against them or costs, fees, expenses or liability (including, without limitation, lawyers’ fees on a solicitor and own client basis) incurred by AAC, the Organizing Club or the Personnel that may arise due to:
 - (a) any act or omission of myself, my Related Parties or any party for whom I am liable at law; or
 - (b) aggressive behaviour by the Dog or any other dog under my control.

I have read, and do understand the rules of competition and the additional rules (if any) appearing in the trial schedule for the Event, as well as the policies of AAC pertaining to discipline (collectively, the “Rules”). disciplinary procedures or sanctions for breach of the Rules and agree to respect and be bound by any disciplinary decision made by AAC.

NOTICE TO EXHIBITORS

Exhibitors, through submission of entry, acknowledge that they are familiar with AAC rules and regulations, including but not limited to the following:

This event is open to all dogs at least 18 months of age, purebred or mixed breed, except bitches in season, aggressive dogs, or dogs suffering from any deformity, injury or illness which may effect the dog’s physical or mental performance.

Obstacles shall be chosen from those described in the current edition of the rules and regulations of the AAC. No leads, collars, food, toys or other aids or devices shall be permitted on the course at any time. No toys or food on course during familiarization.

It is expressly understood that exhibitors alone are responsible for the behaviour of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behaviour may be asked to leave the show grounds and no refund of fees paid will be made. Exhibitors must keep crating and exercise areas clean. Please pick up after yourself and your dogs.

There will be no refund after the closing date for dogs that are withdrawn, with the exception of bitches in season or sick/injured dogs if we are provided with a veterinarian’s certificate.
